## AUDIT SUMMARY

### Results in brief

In the areas we audited, Council operations complied with applicable requirements and provided adequate safeguarding of public resources. The Council also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Wenatchee Valley Transportation Council from July 1, 2011 through June 30, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Council's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Personal services contract
- General disbursements

## INFORMATION ABOUT THE COUNCIL

The Wenatchee Valley Transportation Council was created in 2002 through an interlocal agreement among Chelan County, Douglas County, the city of Wenatchee, the city of East Wenatchee, the city of Rock Island, the Port of Chelan County, the Port of Douglas County, Link Transit and the Washington State Department of Transportation. The agreement created a metropolitan planning organization for the greater Wenatchee urbanized area and to ensure the metropolitan area has continuing, cooperative and comprehensive transportation planning processes. The Council's primary goals are to develop long-range plans for the next 20 years and a six-year transportation improvement program, which is consistent with the long-range plan.

The Council is made up of nine appointed Members. Each Member is appointed by their respective agency to serve on the Council. In the three-year audit period, the Council operated on annual budgets of approximately \$350,000 to \$450,000. The majority of expenditures fund the salaries of the Council's four employees.
