The CDTC Governing Board convened in-person (with an option to participate virtually via Zoom) at the Confluence Technology Center, 285 Technology Center Way, Wenatchee, WA 98801. The public was invited to attend in-person with an option to watch the meeting livestream.

1) Call to Order & Introductions

Upon a quorum, the meeting was called to order at 9:02 a.m. by CDTC Board Chair, Jim Fletcher.

2) Open Public Comment Period

No public comments were received.

3) Approval of Consent Agenda

- March 14, 2024 Draft Meeting Agenda
- February 8, 2024 Draft Meeting Minutes

Upon a motion by Kevin Overbay, seconded by Randy Agnew, the Board unanimously approved the consent agenda as presented. Motion carried.

4) Adopt Resolution 1-2024: Establishing Regional Transportation System Performance Targets

Jeff Wilkens explained to the Board that due to a rule published by the Federal Highway Administration, CDTC was required to adopt a new performance target for the reduction of Greenhouse Gas emissions; a detailed staff report is on file.

Upon a motion by Jerrilea Crawford, seconded by Mark Spurgeon, the Board unanimously adopted Resolution 1-2024, Establishing Regional Transportation Performance Targets. Motion carried. Newly adopted Resolution 1-2024 repealed and replaced existing Resolution 6-2020.

5) Columbia River Crossing Study Presentation

Jeff Wilkens introduced the CDTC Columbia River Crossing consultant project manager, Mark Brower of KPFF. Mark Brower and team presented to the Board different options, advantages, and expenses of a new bridge across the Columbia River from US 2/97 Odabashian Bridge to the Rock Island Hydroelectric Dam area. There was a presentation and discussion only; no action was taken by the Board.

6) CDTC Project Updates

Jeff Wilkens updated the Board on the Pathways Master Plan; several meetings have taken place with an established leadership team. A team/consultant kickoff meeting is scheduled for 11:00 a.m. on March 20, 2024 in the Stevens Pass Conference Room at the WSDOT-NCR building in Wenatchee.

7) Legislative Updates

Jeff Wilkens introduced State Representative Keith Goehner who was in attendance. Rep. Goehner gave a brief update on the recent legislative session and encouraged the Board to communicate with State Transportation Chair, Representative Jake Fey, regarding CDTC transportation priorities.

8) Director's Report

- Jeff Wilkens reminded the Board that because of the annual budget review with the CDTC Executive Committee, there will not be a board meeting in April. The board will reconvene on May 9, 2024.
- CDTC is hosting the quarterly small town/city mayors' luncheon on March 19, 2024 at the Confluence Tech Center in Wenatchee.
